Failure to register as a designated establishment under the Environment Protection Act by the due date is an offence under the Act. On a first conviction, the manager is liable to a fine which shall not be less than 50,000 rupees and not exceeding 500,000 rupees and to imprisonment for a term not exceeding 2 years. On a second or subsequent conviction, the manager is liable to a fine which shall not be less than 100,000 rupees and not exceeding 500,000 rupees and to imprisonment for a term not less than 5 years and not exceeding 10 years.
